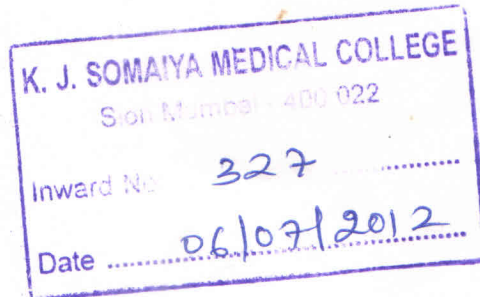



Sir/ Madam,

In continuation to this office letter no. MCI-37(1)/2012-Med/113244 dated 22.06.2012, on the subject noted above, I am directed to inform you that after taking into consideration the claim of the college during the hearing, the Board of Governors decided to reiterate its earlier decision taken at its meeting held on 20<sup>th</sup> June, 2012, i.e. "Not to approve for increase of seats in MBBS course from 50 to 100 u/s 10(A) of the IMC Act, 1956 for the Academic Year 2012-13" which has already been communicated to you vide this office letter dated 22/06/2012.(Copy enclosed)

In view of above, the application for increase of MBBS seats from 50 to 100 at K.J. Somaiya Medical College, Hospital & Research Centre, Sion, Mumbai u/s 10A of the IMC Act, 1956, for the academic year 2012-13 has been disapproved. However, you are free to apply afresh for the next academic year i.e. 2013-14 as there is no provision to keep the proposal pending in the Council office.
